New IDs will be generated based on the AADHAAR authentication through OPT for such applications. All eligible students are therefore, advised to apply/renew for post Matric Schoarship by visiting URL http://www.scholarship.odisha.gov.in.

Eligibility Criteria for post Matric scholarship Scheme:

- i) Student shall belong to ST/SC/OBC/SEBC/EBC community and should be a permanent resident of Odisha.
- ii) The students should continue their post Matriculation Studies in any General/technical or Professional courses in any Govt. or Government recognized Private institutes.
- iii) The annual family income of the parent/guardians from all sources should not exceed Rs.2,50,000/-(Two lakh fifty thousand) per annum.
- iv) In case of OBC/SBC and EBC students, scholarship award will be subject to at least 50 % marks in last qualifying examination.

N.B:-

- 1. Aadhaar is made mandatory for availing scholarship. Please provide correct Aadhar number of self in the online Application form. In case it is found that Aadhaar number provided by the student is wrong or is not his/her, the applications is liable to be rejected.(Ref:-Govt.Notification No.10744 dated.26.06.2019).
- As per Government of India stipulations, payment of scholarship amount will be made ONLY in Aadhaar seeded bank account. Therefore, applicants must ensure that their bankaccount is seded with the Aadhaar number. To seed bank account with Aadhar number.
- 3. A small portion of scholarship(top-up amount in case hosteller students) will be provided in the bank-account details provided in the application. Therefore be very careful in providing account number and IFSSC in on-line application. In case any mis-credit of amount happens due to wrong entry or manipulation for sharing of user id & password with others, Department will not be held responsible and student will be solely held responsible.
- 4. From the year 2023-2024,outside state students(Fresh & Renewal in new course will be covered under the scheme only if studying in Government institutions.
- Login ID would be generated on OTP based Aadhaar authentication, therefore students
 must ensure that their Aadhaar is linked with an operational mobile number to receive
 OTP and provide the same in scholarship portal for successful registration.

6. Basic details i.e Name, Gender, Date of Birth will be fetched from the AADHAAR and will be non-editable. Therefore before registration, students are advised to ensure that these details are correct in their AADHAAR (including spelling of the name & surname).

7. Students applying for the First time or Renewing in New course need to obtained caste and fresh income certificate through e-district portal of Odisha and upload in

the application.

8. Students are required to provide details of all educational qualifications received till date starting from matriculation in concerned section and upload the certificate/mark-sheet of the same.

9. Students must provide an operative, active & unique mobile number (Preferably having whatsapp linked number) to receive important message regarding application status. As per Gol stipulation, one mobile number can be used against only one application.

10. Students are advised to keep their Unique ID & password confidential. In case of any mis-credit/manipulation happens due to sharing of user id & password with others, student

will be solely held responsible..
