

REMUNERATION

The contractual engagement/ Guest faculties/ Part time Lecturers carries the Remuneration of Rs. 500 /- per class/ lecture of 45 minutes of duration subject to ceiling of maximum 50 classes and with Rs. 25,000 /- per month or classes assigned by concerned HOD on the basis of workload.

Term & Conditions:

- 1) Candidates having higher qualifications like M. Phil, NET & Ph.D. will be given weightage.
- 2) No T.A/ D.A. will be paid for attending the Walk-in interview.
- 3) Preference will be given to retired Teachers of Govt. / Aided College below the age of 65 years (max 4 years service admissible) and having requisite qualification.
- 4) This engagement being temporary shall not confer any rights in any manner for regularization of the services of the Guest faculties. At the time of engagement the candidate should furnish an Undertaking to the effect that they will not claim for regularization of their services.
- 5) The Guest faculties so engaged can be disengaged by giving one month notice if their performance is found unsatisfactory. They will also be disengaged consequent upon joining of regular teachers against the said vacant post or in obedience to any future Guidelines, if issued by the Govt.
